# National Ugly Mugs

Fighting stigma, saving lives

# Most sex workers are HIV positive

Most sex workers are addicted to drugs or alcohol

Most sex workers are coerced/trafficked



Being a sex worker is illegal

Sex workers do not look after their sexual health

## Challenging stereotypes

#### <u>Street</u>- 10%-20%

- 90-95% problematic drug and alcohol use
- o 80-85% experience violence
- Mostly female
- Some low-level control partners may be seen as "pimps"

#### Brothel, sauna and parlour- 30-35%

- o Less violence
- High proportion of migrants
- Mostly female or trans female
- o Low levels of exploitation, trafficking and violence

#### Private / independent- 50%

- o Diverse in gender identity and ethnicity
- Working within the law

## 80,000 Sex Workers in the UK

- Launched in July 2012
- Founded by the UK Network of Sex Work Projects
- Funded by Home Office 2012-2013.
- Based on informal "ugly mugs" schemes
- Supported by NCA, NPCC and Home Office.



## National Ugly Mugs

### 10,000 – 15,000 sex workers benefit from NUM

- 3000 Individual members
- 300 Organisations
- 100 Escort sites/establishments

### Reports

- 2100+ incidents since July 2012, 500+ London
- 15% rapes
- 30% sexual violence

## NUM's Reach

- NUM has led to the apprehension and conviction of more than 40 serious offenders who targeted sex workers
- Many of them were serial offenders
- They are now serving a combined total of more than 200 years in prison

Without NUM, police would have known nothing about their crimes.

# 96% felt safer as a direct result of NUM.

78% felt that offenders were less likely to target them now that NUM exists.

## NUM's Impact

#### 1. Reporting and Recording System

A mechanism for members to report incidents via the website, the phone app or to the National Ugly Mugs Team.

**Incident/Attack** 



NUM produces sanitized alerts to warn sex workers and support services of dangerous individuals.

The alerts can be received via:

- •Email/SMS
- Website
- App

With victim consent, intelligence is shared anonymously with the Serious Crimes Analysis Section

## NUM: How it works

Up to 15% SWISH service users identify as transgender

Many are migrant workers who haven't had lower surgery May advertise as either TS or TV

Can enter industry to fund sex re-assignment surgery

Often report feel empowered and valued, offering a specialised service – many of their clients identify as straight men

Access regular sexual health screenings.

Barriers to accessing clinics: binary gendered waiting areas, inappropriate procedures being offered

## **Trans Sex Workers**

- At SWISH 50% of service users are male escorts
- 70% identify as gay or bisexual
- Overlooked in media campaigns when sex work is talked about as gender based violence.
- Can a male sex worker be a victim, and a female feel empowered?
- Male sex workers may work in brothels, but usually online
- Exchanging sex for drugs, favours, or a bed
- Taking drugs/engaging in chemsex can lead to feeling disempowered.

## Male Escorts

- Sex Workers given a lifetime ban on donating blood at the same time as other "high risk" groups
- Clients of sex workers have a 5 year ban
- Indoor sex workers often seen as at low risk of HIV
- Stigmatising suggests sex workers are not in control of looking after sexual health

# **Blood Donations**

Fear of being judged for their work, and concerns around being asked to exit

Pressures of daily life/demands of clients may override health care Immigration status & experiences in country of origin.

Disclosure of sex work and HIV status.

Concerns about lack of understanding around the realities of sex work. Trafficking – 8.7% migrant females have been trafficked (ACPO report)

Fear of being judged by practitioners

Barriers

- "I know you won't report to the police and even if you do they won't believe you because you're a whore"
- "You can't be raped you're a sex worker"
- "What you did wasn't rape, it was prostitution"

## **Sexual Violence**

- Clients calling THT Direct helpline demonstrates misconception that many female sex workers are HIV+
- Many sex workers already set their own boundaries and insist upon protection
- If clients say they are on PrEP, sex workers may feel pressured into participating in bareback sex
- Can lead to increase competition lowering of prices, as clients threaten to take their business elsewhere – a "buyer's market"
- Reconfiguration of power and expectations

## Sex Work & PrEP

Training on what to do if a sex worker discloses criminal activity You can use NUM to send out pleas for information to aid investigations or to help locate missing persons

Link to your specialist service on our website

You can offer an integrated model of working

Intermediary between sex workers, local projects, the NHS, and the police.

More referrals – support setting up a fast track service.

Empowered sex workers they are more likely to access sexual health support services
